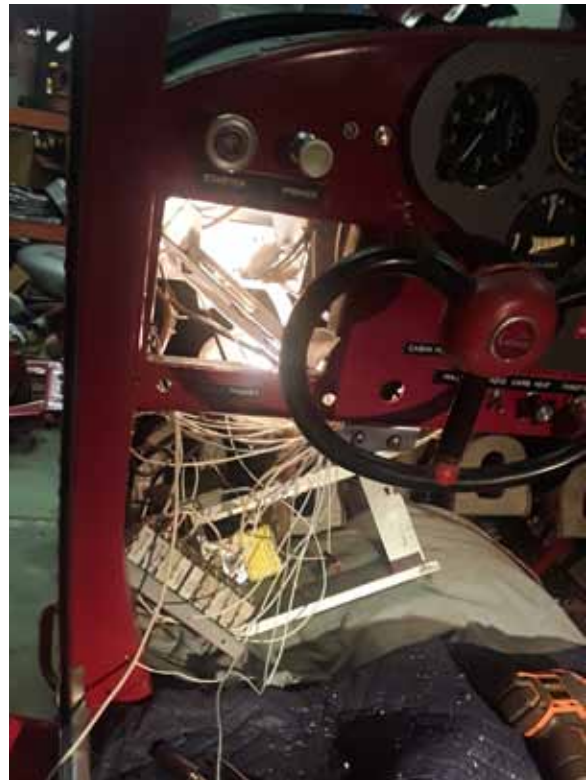

While attending the monthly EAA 377 fly-in at Liberal, she got the chance to talk to members, and learn the importance of General Aviation to agriculture and rural America.

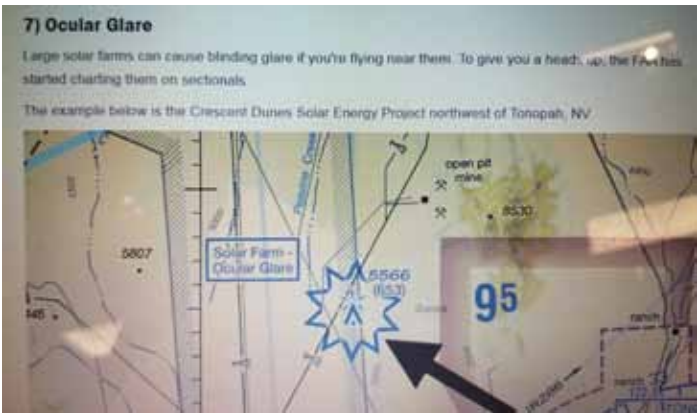

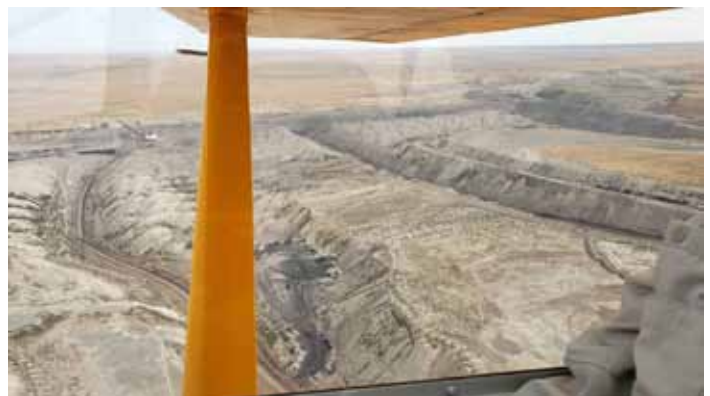

New Cessna AD Requires Inspection for Cracks at Strut Attach Fitting

The FAA has adopted an Airworthiness Directive (AD) for certain Textron Aviation Inc. Model 172, 182, 206, 207, and 210 airplanes. The AD, prompted by cracks found in the lower area of the forward cabin doorpost bulkhead, requires repetitively inspecting the lower area of the forward cabin doorposts at the strut attach fitting for cracks and repairing any cracks. This AD, which affects 14,653 airplanes of U.S. registry, is effective Nov. 12, 2020. SUBJECT: CASE NO. 20-ANM-57NR

**PROPOSED DECOMMISSIONING
Goodland VOR
Goodland, Kansas**

The intent of this notice is to inform the public of the proposal to decommission and remove the Goodland Very High Frequency Omnidirectional Range (VOR) (GLD) and provide an opportunity to comment.

The FAA has adopted a strategy to gradually reduce the current VOR network to a Minimum Operating Network (MON) as the National Airspace System (NAS) transitions to performance-based navigation (PBN) as part of Next Generation Air Transportation System (NextGen). Information about the VOR MON program may be found in Federal Register Docket #FAA-2011-1082-0354. As part of the VOR MON program, GLD has been identified for decommissioning. The FAA is, therefore, conducting a non-rulemaking study to determine the feasibility of decommissioning GLD. If approved, decommissioning would take place in 2025.

Decommissioning GLD will cause cancellation of the Renner Field/Goodland Municipal Airport Runway 30 VOR/Distance Measuring Equipment (DME) instrument approach procedure. Airways anchored by GLD will be rerouted, canceled, or replaced with Global Positioning System (GPS)-based Q and T routes. Airway mitigations will be determined by future rule-making studies.

OPPORTUNITY TO COMMENT: Interested parties are invited to respond to this proposal by submitting written data, views, or arguments. Comments are specifically invited on the overall aeronautical, economic, environmental, and energy-related aspects of the proposal. All communications received on or before the specified closing date for comments will be considered before taking action on the proposal. The proposal contained in this notice may change in the light of comments received.

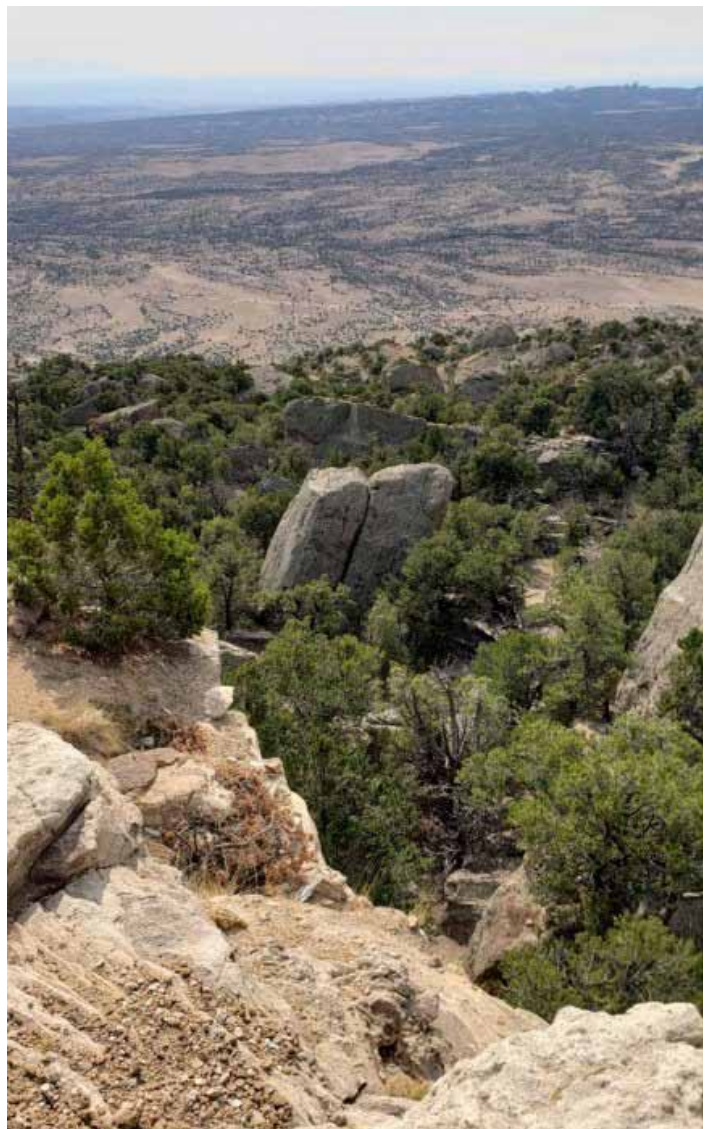
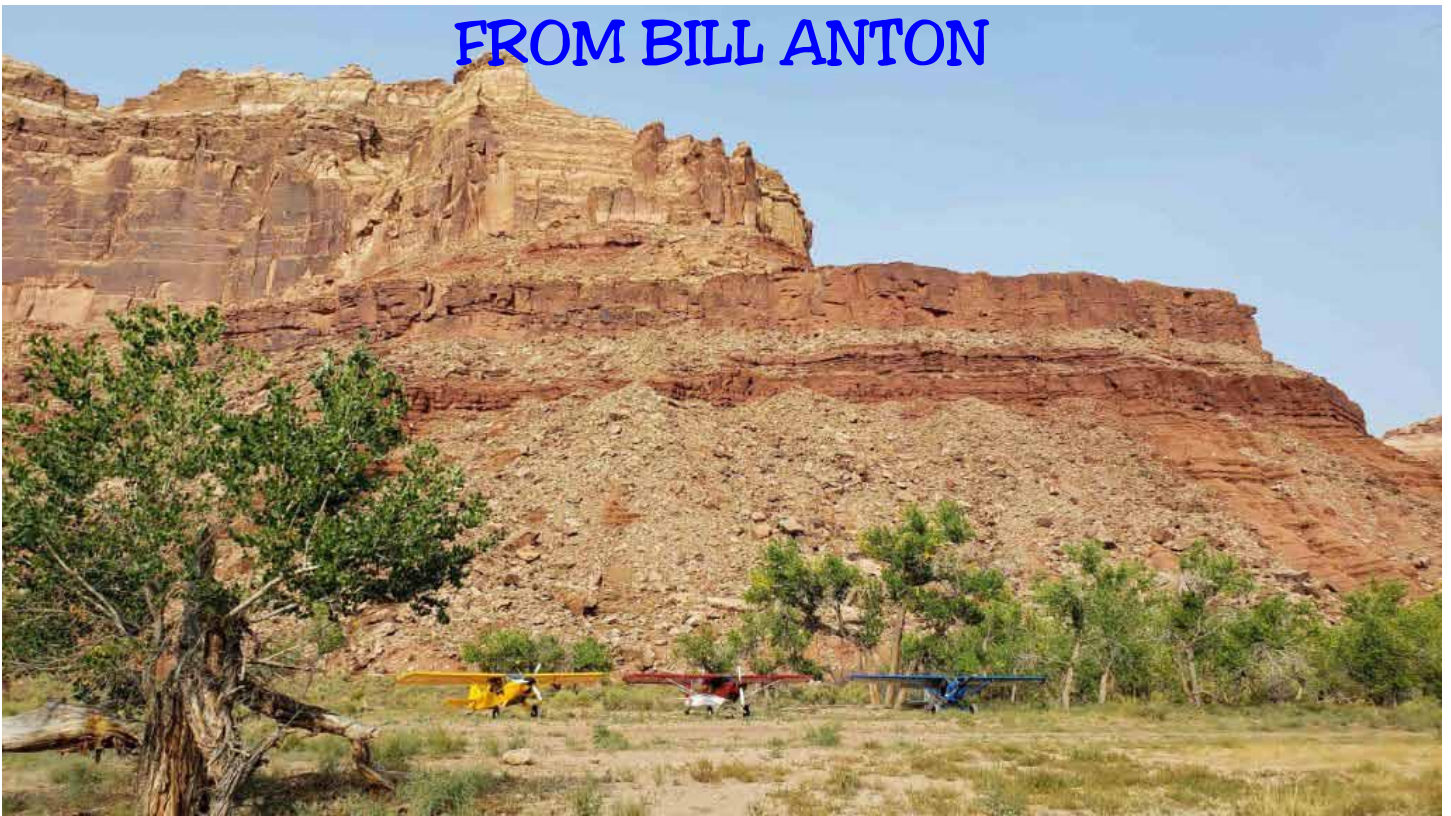
